3. Implementation of ESI - For consideration & decision

As directed by the central office (DDMS) and auditors concerned and as per the information found from other colleges and the ESI act, it is proposed to implement ESI facility for all staff earning less than Rs. 21,000/- as salary per month.

As per the ESI Act 0.75 percent is employees contribution and 3.25% is employer's Contribution (copy attached). If this is followed the additional financial Commitment as on 31.01.2021 is Rs. 3, 74,520 per annum for the college (copy attached), which can be met from unaided surplus funds. The 39 th Finance Committee in its meeting held on

27.03.2021 after deliberations resolved to recommend to the higher bodies to approve the ESI scheme to all eligible employees of the college, meeting the additional financial commitment of Rs.3, 75,000 from surplus funds of unaided account.

The matter is communicated for decision and if agreed the following resolution may be approved.

"Resolved to approve the ESI scheme to all eligible employees of the college, meeting the additional financial commitment of Rs.3,75,000 from surplus funds of unaided account."

4. <u>Implementation of PF Scheme for eligible employees</u>- For consideration and decision. PF scheme is already offered to the staff of the college. Some more members who have completed 3 years of service applied to include them in PF scheme. As on 31.03.2021 details submitted by the office are as follows (copy attached).

The total additional commitment is Rs. 1, 75,000 per annum.

The 39 th Finance Committee in its meeting held on 27.03.2021 after deliberations resolved to recommend to the higher bodies to implement PF Scheme for eligible employees who were not covered thus far at the rate of 12% on Rs. 15,000/- amounting to Rs. 1800 per head plus 1% administration charges totaling Rs1950/- per head.

The matter is communicated for decision and if agreed the following resolution may be approved.

"Resolved to implement PF Scheme for eligible employees who were not covered thus far at the rate of 12% on Rs. 15,000/- amounting to Rs. 1800 per head plus 1% administration charges totaling Rs1950/- per head".

5. Request of staff, both Teaching and Non – Teaching for pay revision-For consideration and decision.

A proposal was submitted to the 16th Administrative Committee meeting convened on 26th February,2021 for the said Pay revision at the rate of 10%. After thorough deliberations, it was decided by the august body to resend the matter to the FC for a detailed proposal.

The detailed proposal is placed here for consideration and approval:

a) 10% of the salary drawn as on 31.03.2021 is the proposed revision for all the employees with minimum of 2 years' service in the college.

14.8 Approval of appointment of teaching staff

Secretary informed the members that a selection committee has been constituted for selection of teaching staff. On our intimation internal teaching staff who do not have PF facility and who have not acquired SLET/NET have applied apart from outsiders. Online interviews were conducted inviting subject experts from Osmania University. The selection committee selected the following candidates. The details along with salaries offered are given below:

- a. Dr. Rohini Rondla (organic chemistry) as Assistant professor in the Department of Chemistry on temporary basis for the year 2020-21 (in the pay scale of Rs.15,600-39,100 with AGP of Rs.6000). on Rs.28,300 consolidated per month.
- b. Mrs.V.Shanthi, as Assistant professor in the Department of Commerce on temporary basis for the year 2020-21 (in the pay scale of Rs.15,600-39,100 with AGP of Rs.6000) on Rs.25,000 consolidated per month
- c. Mrs. Shakunthala Jain, as Assistant professor in the Department of Commerce on temporary basis for the year 2020-21 (in the pay scale of Rs.15,600-39,100 with AGP of Rs.6000) on Rs.25,000 consolidated per month.

Further it was informed that in view urgency of recruitment of teaching staff the selected candidates were given appointment orders and they reported to duty. The performance all other teaching staff who are already working was not up to the mark as per the experts. Hence it was resolved by the selection committee to continue all existing staff who have attended the interview both from Commerce and Management and other subjects, however their salary and academic improvement conditions of continuation will be decided keeping the minimum requirement for all the staff as per the UGC norms Members deliberated on this matter and finally approved the selection committee's decisions.
