It is discussed to initiate further measures for bridging the gap between Industry and the Institute. Faculties are suggested to visit different companies for exploring the possibilities of activities such as Internship, Industry Projects, Guest /Expert Lecture, Placements, etc. Also, further efforts are required for Identification of Industry for Consultancy, Collaborative work.



Members suggested the publication of testimonials (in the form of short videos) on the website by students to encourage other students.

### 36.4 Suggestions on AQAR 2022-23

The progress of data collection for AQAR 2022-23 submission by all the Criteria convenors was reviewed/

As part of AQAR submission. All members agreed to work on strengthening the website.

Workshops focusing on quality, leadership, and career guidance were recommended, alongside adherence to Bloom's Taxonomy and the Kit Comprehensive Analysis Apprehensive Synthesis Evaluation model to enhance learner attainment levels.

The discussion further encompassed the maintenance and implementation of autonomy in documentation practices. Critical topics included the identification of employability skills, the framework of outcome-based education (OBE), and the graduate attributes reflecting programme outcomes. An analysis of how course outcomes (CO) correspond with programme outcomes (PO) was to be undertaken.


### 36.5 Any other matter with the permission of chair

The members suggested to be ready with the documentation of SSR. The criteria heads are assigned with respective works concerned with SSR.


The members also agreed on more industry tie ups for providing internship to students to support their academic syllabus





