She suggested that Programme Specific Outcomes may be designed from 3 to 5 in number based on the programme. PSOs for B.Com course were displayed.

It was discussed that the Course Outcomes are to be designed based on Blooms Taxonomy of Learning flow chart as followed -

Remember, Understand, Apply, Analyze, Evaluate, Create.

She emphasized to categorize the COs designed into the above Blooms Taxonomy levels.

She has explained the process of COs, PSO, mapping, Setting weightage, Direct and Indirect Assessment Methods

For Internal Assessment, Grade points may be awarded from 0 to 3

Each counsellor can specifically find out their respective average of CIA and Semester End Examination.

Assessment of COs, finding out internal and external weightage was highlighted.

She suggested to have an Indirect attainment feedback of the particular teacher or subject from students and calculate the overall average rating.

She focussed on Mapping Courses With Program Specific Outcomes (PSOs).

And PO and PSO Attainment Process as

Programme Outcome Attainment

= (Weighted Average Value of PO * CO Attainment Average) / 3
